In the event that your animal becomes ill, said that the animal will be taken to their personal vet as you have previously designated in writing to Colonial Kennels. Additionally, any services provided by and for said pet by either your personal veterinarian, or emergency veterinarian, said services and/ or costs shall be completely paid by owner. Additionally in the event damage, harm or any emergency in the sole discretion, you as the owner, give permission that the aforementioned veterinarian may perform any measures necessary in the best interest of the animal. Colonial Kennels in the event of the aforementioned emergency, will contact you the owner through the provided emergency number to the extent possible. Additionally, you as the owner shall identify and hold Colonial Kennels harmless from any and all charges provided by said emergency veterinarian or the owners personal veterinarian due to the aforementioned emergency or the necessity of providing medical care to your pet.

In engaging/ hiring Colonial Kennels for kennel services, you as owner acknowledge and consent that you are the legal owner of said animal and are responsible for any and all of the aforementioned costs and fees associated with said pet care.

Additionally, you acknowledge that your animal has not been exposed to any contagious disease, parasites or rabies within the last thirty (30) days and said animal is vaccinated with all required shots and said animal has the appropriate and relevant annual license.
